



RIDER

A Kantasy performance consists of a professional grade plug-and-play DJ set mix, with fully synchronized and personally designed visuals, and choreographed go-go dance performance with no breaks. In order to achieve this level of high octane performance, the following provisions are required:

Basics:

- A stipend of \$200 per hour of performance, with a maximum of 3 hours, that is accessible within 7 days of the performance.
- Minimum of 3 water bottles that are accessible on stage.
- Access to a wireless microphone.
- 2 compensated event tickets (for myself and my handler).
- Access to any backstage areas, green rooms, or similar areas that standard attendees cannot access.
- No additional go-go dancers on the stage during the duration of the performance.
- Stage access for the handler.
- Shared ownership between the event and Kantasy for any media shot and/or posted of the performance.

Branding Requirements:

- Good faith effort from the event's social media to promote the performance before the event using images and assets provided by Kantasy.
- Good faith effort from the event to include the promotional images in the programming, schedule, and any other media that contains information about the time and place of the performance.
- Good faith effort to include Kantasy branding in any extracurriculars such as drink menus, convention and website banners, displays, etc.

Travel ([January 1st, 2026 - July 1st, 2026](#))

- If the venue is greater than 20 miles, but less than 999 miles from **Phoenix, Arizona**, then lodging must be covered or reimbursed within 7 days of the event ending. A one queen style room is preferred.
- If the venue is further than 1,000 miles from **Phoenix, Arizona**, lodging & **airfare for two** (myself and my handler) must be covered or reimbursed within 7 days of the convention ending.

Travel ([July 1st, 2026 - December 31, 2026](#))

- If the venue is greater than 20 miles, but less than 999 miles from **Austin, Texas**, then lodging must be covered or reimbursed within 7 days of the convention ending. A one queen style room is preferred.
- If the venue is further than 1,000 miles from **Austin, Texas**, lodging & **airfare for two** (myself and my handler) must be covered or reimbursed within 7 days of the convention ending.

Convention Addendum:

If the performance event is hosted on property by a fandom related convention that is themed around: anime, comics, movies, video games, vTubing, and/or hentai, then **one guest or artist alley booth for the full weekend must be provided.**

The Standard:

A typical Kantasy performance is 90 minutes in exchange for \$300, and included is the punctuality to interact with fans during the entire duration of any Exhibitor hours at an assigned booth space.

The convention will receive access to Kantasy during all hours of the event, and can expect good faith effort for promotion from Kantasy across all branded channels, as well as eagerness to interact with attendees and promote the performance via word of mouth.
